- 1) I, the undersigned (hereinafter called the "Consumer"), do hereby request the Municipality to provide sewage and/or water service at the premises listed above, and I undertake and agree to be bound by the rules and regulations and general conditions as may be established from time to time by the Municipality in regard thereto.
- 2) The Consumer vacating the above-listed premises without notifying the Municipality is liable for all subsequent accounts until a new consumer is registered at the vacated location. It is the Consumer's responsibility and in his best interest, to advise the Municipality in writing when he vacates the premises where he was registered for sewage and/or water service.
- 3) The Consumer agrees that on request of the Municipality, at its discretion, he will make a deposit to be held by the Municipality without interest as a guarantee that the Consumer will fulfill all the terms of this agreement.
- 4) The Consumer will provide all plumbing on the premises and all building sewers and/or private water services connecting the premises with the point of connection with the Municipality's water and/or sewage works and maintain the same in efficient condition with proper devices.
- 5) The rates charged for sewage and/or water service are subject to change at any time on receipt of notice from the Municipality.
- 6) This agreement shall continue in force from year to year until terminated by a notice in writing, given by either party hereto at least one month before the end of the term or any year term thereafter.
- 7) The Consumer agrees not to make any changes in or additions to his plumbing or connecting building sewer line and/or connecting private water service lines after the same has been installed by the Consumer and inspected by the Municipality except with the written consent of the Municipality.
- 8) It is agreed that the signatures of the parties hereto shall be binding upon their successors or assigns, and that the vacating of the premises herein named shall not release the Consumer from this agreement, except at the option and written consent of the Municipality.
