Public Notice

The Study

The Township of North Stormont has completed a Schedule C Class Environmental Assessment (Class EA) study for the proposed expansion of the existing Moose Creek Wastewater Treatment Lagoon (WWTL).

The need for additional storage and treatment capacity at the existing Moose Creek WWTL was identified in the 2024 Master Servicing Plan for Water and Wastewater undertaken by the Township.

Additionally, the WWTL is currently operating at greater than 86% of rated capacity and is expected to exceed capacity by 2028. The Township has also received funding through the HEWSF grant, requiring expansion implementation to be completed by 2027. Hence, the need for immediate upgrades is critical.

The expansion shall be implemented within the property boundaries of the existing site, as shown in the adjacent figure.

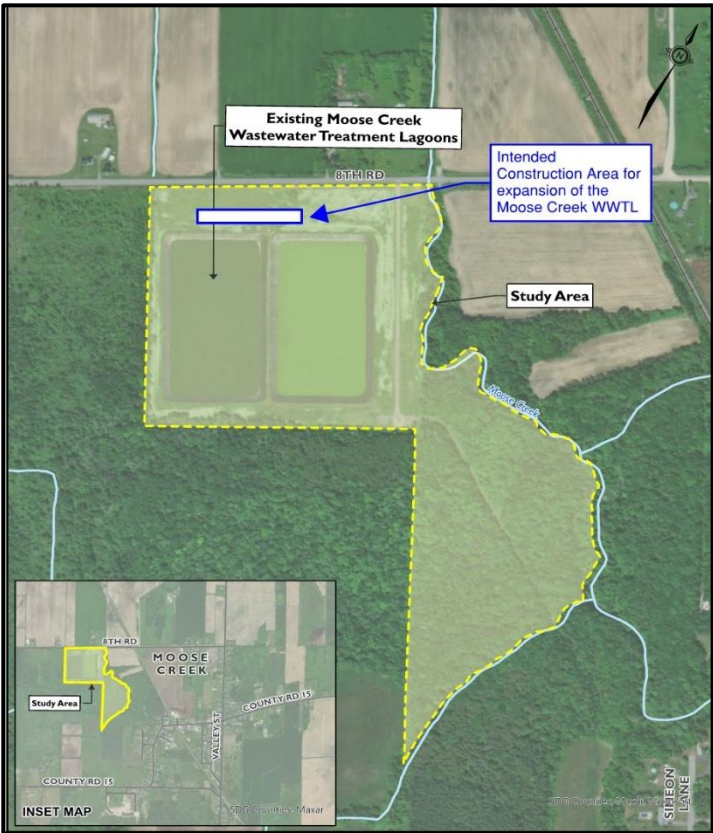


Figure 1: Location of Expansion works within the Project Study Area

The Process

The Class EA study has been completed as per the requirements of a Schedule ‘C’ project of the Municipal Class Environmental Assessment document (October 2000, amended in 2007, 2011, 2015, 2023 & 2024). Alternative design concepts for the WWTL expansion were identified and evaluated as part of the study to minimize technical, socio-cultural, natural environmental and economic impacts. Measures to alleviate any adverse effects that may result from the construction of the proposed works have been recommended.

The preferred design concept for the Moose Creek WWTL expansion includes:

- **Technology:** Two (02) Submerged Attached Growth Reactors, for implementation as a retrofit with the existing lagoons
- **Effluent discharge:** as a twice-a-year discharge, with the addition of a Fall discharge window

The preferred design concept will also include associated upgrades for piping, pumping, aeration, etc.

Environmental Study Report

The Class EA Environmental Study Reports (ESR), detailing the planning process, findings, and recommendations for the study will be available for public review for 30 calendar days from October 20, 2025 to November 20, 2025. In addition, a request may be made to the Ministry of the Environment, Conservation and Parks for a Section 16 order requiring that the proponent of a project going through a Class EA process:

- 1. Submit an application for approval of the project before they proceed; or,
- 2. Meet further conditions in addition to the conditions in the Class EA.

The public may request the Minister to make a Section 16(6) Order only if:

- 1. They have outstanding concerns that a project going through a Class EA process may have a potential adverse impact on constitutionally protected Aboriginal and treaty rights; and,
- 2. They believe that an Order may prevent, mitigate, or remedy this impact.

If a member of the public wishes to request a Section 16 Order for a project, on the grounds that an Order may prevent, mitigate or remedy potential adverse impacts on constitutionally protected, Aboriginal and treaty rights, this request must be made before the public comment period is complete.

Section 16 Order requests must be sent to the Minister of Environment, Conservation and Parks and the Director of Environmental Assessment Branch, and can be submitted by mail, email, fax, or hand delivered to :
