**TAKE NOTICE THAT** an application under the above file number will be heard by the Committee of Adjustment on the **5<sup>th</sup> day of December at 8:30 A.M. at the Township of North Stormont Municipal Office, Berwick, ON**, under the authority of Section 45 of the Planning Act.

**THE PURPOSE OF THE APPLICATION** is to provide relief from section 3.22 of the Zoning By-Law 08-2014 to permit a reduction in the Minimum Distance Separation (MDS) setback from 237 m to 172 m from a neighboring dwelling.

**THE EFFECT OF THE APPLICATION** The proposed MDS reduction would allow for the construction of a new concrete manure tank.

**ADDITIONAL INFORMATION** relating to the application is available for inspection during normal office hours at the Township of North Stormont Office, located at 57A Cockburn Street, Berwick, ON.
